Terms of Participation

To be an approved affiliate of Giarc, LLC, you agree to abide by the terms and conditions contained in this agreement.

Please read this agreement carefully before registering and using the Giarc, LLC service as an affiliate. By signing up for the Giarc, LLC affiliate program, you indicate your acceptance of this agreement and its terms and conditions.

***NOTE: You must complete, sign, and submit the required W-9 or W-8BEN form (for Non-US citizens) in the [affiliate back office](#), as outlined in term 10 below. Commissions will not be awarded until this form is received by Giarc, LLC.

AFFILIATE PROGRAM TERMS OF PARTICIPATION

1. Upon completion of this sign up form, you are approved as an affiliate of the Giarc, LLC affiliate program and agree to comply with the Terms of Participation in this document. Only approved affiliates can earn commissions and refer new affiliates.

2. During the Beta phase, an affiliate may share about Biominix products and Biominix.com only by: personal communication; or the personal distribution or

sharing of marketing materials or other digital resources provided to you in the affiliate back office; or as approved by Giarc, LLC.

3. As an affiliate, you may submit marketing materials for consideration and possible approval to: support@biominix.com.

4. Use of the Biominix name within domain names, subdomains, e-mails, or social media account names is strictly prohibited. Biominix is a protected name and no representations may be made by you that indicate, suggest, or state that you represent the opinions, viewpoints or official positions of the company.

5. No claims, statements or declarations shall be made by you directly or indirectly, as to the efficacy of the Biominix products, or their value or benefit as a treatment or cure for any illness, disease, symptom, or condition. All questions about Biominix products are to be directed to the Biominix.com website.

6. As an affiliate, you, your heirs, assignees or representatives, agree to hold harmless from any legal action of any description or form or type, Mitigation of Diseases Inc., Giarc, LLC, LLC, Biominix, LLC, JW Kennedy Foundation and any Officers, Directors, Employees, Associates, Affiliates or other persons or entities associated with said groups, organizations or companies.

7. As an affiliate of this program, the commission you will be paid by Giarc, LLC is as follows: 10% on the purchase price of Biominix products by others who use your affiliate link, 5% on the purchase price of Biominix products which use the affiliate link of an affiliate referred by you, and a discount on the purchase of Biominix products as an affiliate. 8. Commission payments by Giarc, LLC to affiliates will be made on or about the 15th of the month for sales of Biominix products made the month prior.

9. Succession. Upon the death of an affiliate, the affiliate account shall pass by will or interstate succession, as provided by law. Giarc, LLC will require the successor in interest to sign and be bound by the then current affiliate agreement. The successor shall then be entitled to all the rights and subject to all the obligations, just as any other Giarc, LLC affiliate.

10. Accurate and full completion of the W-9 (including signature), or W-8BEN for those who are not a US citizen, is required in order to be paid by Giarc, LLC. Check the appropriate box for Individual or Type of Business, as defined in the instructions on the form. Affiliate payments shall be made by company check to Affiliates during the Beta phase.

11. Your affiliate number will be sent to you upon registration as an affiliate with Giarc, LLC.

12. Giarc, LLC may change the Terms of Participation for the Affiliate Program at any time. Posting of these changes on the Affiliate website is considered notification of said changes. Giarc, LLC may, at their discretion, notify you of any changes through sending notice to your email on file. Continued participation in the Beta Affiliate Program after notification shall be considered acceptance of the change in the Terms of Participation.

The Company's official language is the English language and affiliates or purchasers of Biominix products should always read and refer to the main Website for all information and disclosures about the Company and its products. Translation or information provided in languages other than English is for
